### **5. Oral Report of PAOC representations at PAEC meetings**

Brendan O’Dea represented the PAOC at the PAEC meeting of 28 November 2023.

Specific points that Brendan noted:

- Recommends PAOC members observe the PAEC as it’s a useful experience.
- Committee is well attended with many members and is well Chaired.

- Chair is inclusive, provides background on the processes for observer's information.
- Wide range of programmes, extraordinary variety of activity by QQI.
- Worthwhile experience - felt it was a robust system, and that the staff are on top of the work – very reassured.
- Remarked that PAOC members noted the heavy workload associated with low credit programmes but does not object as the benefits of the process are clear.
- Remarked on the low number of refusals considered by the PAOC annually, this is in part due to QQI staff managing and supporting applications.
