6. REVALIDATION

6.1 Application for Extension of Validation Period

6.1.1 CCT College Dublin

The Committee NOTED the documentation circulated. CCT College requested a one-year extension of validation for the following programmes:

6.1.1.1 PG24349, Higher Diploma in Science in Data Analytics for Business, Level 8, Major Award, 60 Credits

PG24350, Higher Diploma in Science in Artificial Intelligence Applications, Level 8, Major Award, 60 Credits

The rationale for this request was as follows:

CCT College Dublin indicated that they wished to extend the duration of the above programmes by one year due to the strategic planning activities for the coming four years by the College's Executive Leadership Team. The College are planning to engage in external quality assurance activities such as the TrustEd process and the CINNTE review cycle and also intend prioritising programme review and

revalidation activities for the *PG23756 Bachelor of Arts (Honours) in Business* and *PG24244 Bachelor of Science (Honours) in Computing and Information Technology* in this academic year 2024/2025. To facilitate workload balance and a realistic timeframe for the strategic planning and to focus on programme priorities over the coming four years, CCT College Dublin were therefore requesting an extension of one year for the above programmes.

The Committee APPROVED the request to extend the last intake date of the programmes for one year.

6.1.2 City of Dublin Education and Training Board

The Committee NOTED the documentation circulated. City of Dublin Education and Training Board (CDETB) requested a one-year extension of validation for the following programmes:

6.1.2.1 PG24146, Higher Certificate in Dental Nursing, Level 6, Major Award, 120 Credits

The rationale for this request was as follows:

CDETB indicated that they wished to extend the duration of the above programme until September 2025. Further to a recent review of the programme conducted in preparation for the revalidation process, it has been recommended that the current programme be converted to a national apprenticeship to better respond to industry and learner needs. In consequence, work is underway to develop this new apprenticeship programme, and it is envisaged it will take 18 - 24 months to complete same. An extension was requested to facilitate the smooth transition from the current programme to the new apprenticeship programme.

The Committee APPROVED the request to extend the last intake date of the programme for one year to September 2025.

6.1.3 Independent College

The Committee NOTED the documentation circulated. Independent College requested an extension of one year of validation for the following programme:

The rationale for this request was as follows:

Independent College indicated that they wished to extend the duration of the above programme for one year, to cover the interim period not covered ahead of the revalidation application which has been submitted to QQI and will be considered at a PAEC meeting in early 2025.

ICPPD indicated that they are in the process of reviewing and revalidating the above programmes. This has been a prolonged process and ICPPD wished to extend the duration of the above programmes until September 2024 to cover the interim September intake ahead of these programmes being revalidated. ICPPD's revalidation application was on the agenda for this PAEC meeting.

The Committee APPROVED the request to extend the last intake date of the programme to September 2024.

The Committee NOTED the verbal update by the Executive on recent engagement with SOLAS and DFHERIS regarding revalidation of 20 craft apprenticeships and the subsequent roll-out. Following discussion, the Committee AGREED that the executive write to SOLAS to highlight the imperative and urgency of ensuring that the programmes are implemented as approved, and in particular that new assessments have been devised and deployed. The Committee requested that SOLAS provide a written implementation report for each PAEC meeting in 2025.

6.3 Application for Modification of Validated Programmes

6.3.1 Dublin Business School

The Committee NOTED the documentation circulated. The modification request relates to an increase in the maximum enrolment numbers from 50 per intake to 100 per intake. This would increase the total enrolment per annum from a maximum of 250 to a maximum of 500.

At its meeting on 21 September 2023, the PAEC approved the QA procedures of Liberties Inchicore Rialto Training with two Conditions of QA Approval.

At its meeting on 21 September 2023, the PAEC noted that the Executive considered the conditions of QA approval number 1 to be met. On 11 September 2024 Liberties Inchicore Rialto Training confirmed that it had addressed condition number 2 and outlined what actions have been taken by the provider in respect of the condition.

The Committee NOTED that the Executive is satisfied that the conditions of QA Approval have been appropriately addressed and that no further follow-up is required.

13. INTENTION TO WITHDRAW VALIDATION OF PROGRAMMES

13.1 Intention to withdraw validation of programmes

The Committee NOTED the documentation circulated.

This Committee was requested to approve the withdrawal of validation from programmes listed in the documentation where:

- A. the programme has been replaced through revalidation or which is no longer offered by the provider
- B. the programme's validation period has expired, and it has not been used for certification for a prolonged period of time
- C. the provider no longer has its quality assurance approved by QQI.

Withdrawal of validation from revalidated programmes is part of the normal programme lifecycle. QQI has begun the process of withdrawing validation from ETB programmes which have long exceeded the normal five-year period of validation. This process will continue, PAEC meeting by PAEC meeting, with a view to reducing the number of

programmes validated for ETB providers. This number is currently 3,591. The 103 programmes presented to this PAEC meeting are validated to lead to CAS awards which have not been achieved by any learner in *any ETB* in the last two years at least. In future, the selection of programmes will focus on those uncertified in each ETB.

Saint Nicholas Montessori College has ceased to offer its validated programmes.

All providers are aware of QQI's intention to withdraw validation.

The executive will request InfoPulse to change the status of these programmes to 'Withdrawn'.

The committee APPROVED the withdrawal of validation of the listed programmes.

14. WITHDRAWAL OF VALIDATION OF PROGRAMMES/WITHDRAWAL OF PROVIDER QA APPROVAL

14.1 Saint Nicholas Montessori College Ireland (SNMCI)

The Committee NOTED the documentation circulated.

On 12 March 2024, QQI notified the Qualifications Advisory Board (QAB) for the Early Learning and Care Sector, that SNMCI had formally advised QQI of its intention to cease operating at the end of 2023/24 academic year and that QQI was actively engaged with the provider to ensure the successful transfer of impacted learners to alternative providers to complete their programmes under the Protection of Enrolled Learners.

On 20 August 2024, QQI received a formal letter from the CEO of SNMCI to confirm that they were informing QQI of the closure of SNMCI and outlined the reasons for this.

The committee APPROVED the withdrawal of approval from Saint Nicholas Montessori College's quality assurance procedures and the withdrawal of validation of its programmes.

14.2 Steer Training Academy

The Committee NOTED the documentation circulated.

On 30 October 2024, QQI received a letter received from Steer Training Academy formally advising QQI of their decision to withdraw from QQI QA approval.

The committee APPROVED the withdrawal of approval from **Steer Training Academy's** quality assurance procedures.

15. ANNUAL SELF-ASSESSMENT OF THE PERFORMANCE OF THE COMMITTEE – 2023

15.1 Annual Self-Assessment of the Performance of the Committee – 2023

The Committee NOTED the documentation circulated. This included the responses to the survey on the self-assessment of the performance of the PAEC for 2023.

QQI is required under the Code of Practice for the Governance of State Bodies (2016) to carry out an annual self-assessment of the Board and its Committees. All members of the PAEC at the end of 2023 were invited to partake in a self-evaluation of the performance of the PAEC through a short survey. All seven members responded to the survey.

The areas addressed included Roles and Responsibilities; Composition and Conduct of Committee Meetings; Adequacy of Committee Information; and Communications.

An initial analysis of the responses indicated that the Committee is very satisfied in the majority of areas covered by the evaluation.

The Committee noted the responses to the survey including the greatest strengths as a committee, and where the committee should be taking action to improve its effectiveness.

The feedback provided at the meeting included the following:

- The Committee agreed that the following function in the Terms of Reference needs to be modified:
Carry out an internal quality assurance role in respect of the operation of standards determination which includes monitoring routine awards standards operations (including tracking executive adjustments to awards standards), providing feedback on same, and monitoring provider experiences in using standards.

It should be re-stated to make it appropriate for the use of Programme Derived Award Standards (PDAS).

- It may be helpful for new members during the induction process to be shown how to navigate the papers.
